## All-things-employment in one very helpful training

Indiana is now one of five states offering **Family Employment Awareness Training (FEAT)**. You're probably already aware that transition to adult life and support services can be complicated.

**FEAT gives transition-age students, young adults with disabilities, families, and caregivers the chance to see beyond complications to real possibilities.**

**Things to know:** Training is **FREE**, it's online, and it's this month! Register now to participate in a series of **Zoom sessions taking place October 20-30**. These trainings provide extensive information about employer and employee supports, benefits, work incentives, and savings. And you can hear from Hoosiers who are making it work.

Your FEAT hosts are team members of IN\*SOURCE and the Center on Community Living and Careers (CCLC). IN\*SOURCE is Indiana's parent and training information center; CCLC is a center of the Indiana Institute on Disability and Community and focuses on transition, employment and adult services. FEAT is sponsored by AWS Foundation. These are all people who understand the state's systems of employment, benefits, and service supports. They don't want to sell you anything; they want to help you see how
